- 1) Google form filling by the regular final year batch of 2019-20 students who want to appear for the online exam.
- 2) The regular Sem VI & backlog Sem V forms to be filled offline (for only across all TYs, MA/MCOM PART I & MSC) students 2019-2020 batch).
- 3) Three sets of MCQs, to be made for each subject of Semester VI, every set shall have 40 questions which will cover the entire syllabus out of which the student can answer 30 questions. (total 120 MCQs, marks distribution per MCQs -2 Marks)
- 4) For the backlog MCQs, one set per 10 students.
- 5) Practical's exam time-table to be put up by 9th of September, 2020 and shall be conducted from 15th of September, 2020 to 29th September, 2020.

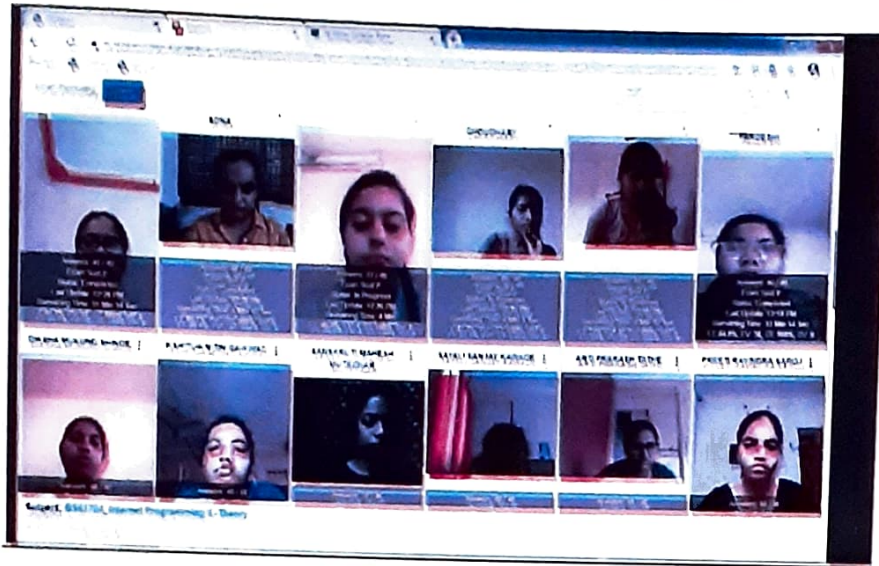
