- 3. (a) You will be paid basic pay of Rs. 8.000/- per month in the scale indicated above. You will also be entitled to dearness allowance, house rent allowance, and C.L.A. at the rates prescribed by the state government from time to time. In case you are appointed for a period of more than one year you shall earn annual increment.
  - (b) You will be paid remuneration at the rate of Rs /- per lecture/per hour.
  - (c) Your appointment and salary shall be subject to approval by the University of Pune and Joint Director of Higher Education as the case may be.
- 4. (a) You shall have to qualify the NET/SET or similar test (as the case may be) laid down by the University or the state Government/UGC or the Central Council pertaining to your faculty within the stipulated period.
  - (b) You shall have to acquire the qualification (M. Phil /Ph.D., M.D./M.S., M.E. etc. as prescribed by the University/state govt or the Central Councils concerned within the \_\_\_\_\_period.
- Your appointment is subject to the minimum number of students and the work- load prescribed for the post.
- 6 You shall submit the originals as well as certified true copies of relevant testimonials such as birth date certificate, mark-sheet, experience certificate, discharge certificate, last pay certificate, caste certificate, change of name (if any), before joining your duties.
- In case you accept the appointment you shall have to execute deed of contract of service as prescribed in the statutes at the time of joining the duties.
- 8. You will be allowed to join the duties on producing of:-
  - (a) Two passport size photographs.
  - (b) Character Certificate from two eminent persons, one should be a Govt. Gazetted officer
  - (c) Discharge certificate from previous employer (if any).
