- (b) You will be paid remuneration at the rate of Rs. ____per lecture/per
- (c) Your appointment and salary shall be subject to approval by the hour. University of Pune and Joint Director of Higher Education as the case may be.
- (a) You shall have to qualify the NET/SET or similar test (as the case may be) laid own by the University or the state Government/UGC or the Central Council pertaining to your faculty within the stipulated period.

- 10. You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier should be communicated to the Principal.
